



A Resolution Dissolving the Richfield City Redevelopment Agency.


Whereas, the minutes of the meetings held in June of 2006, by the governing body of the Richfield City Redevelopment Agency acknowledge that taxes would not be collected beyond the fiscal year 2006-2007 and that by law the Redevelopment Agency would be terminated or dissolved consistent with state law and the ordinances creating the Redevelopment Agency; and

Whereas, the City of Richfield has not utilized the Redevelopment Agency for the collection of taxes or otherwise since fiscal year 2006-2007;


NOW THEREFORE, IT RESOLVED BY THE CITY COUNCIL OF RICHFIELD, STATE OF UTAH:


