RESOLUTION 2025-03

A RESOLUTION OF THE BOARD (THE "BOARD") OF THE UTAH FAIRPARK AREA INVESTMENT AND RESTORATION DISTRICT, UTAH ("UFAIR"), PROVIDING FOR THE CREATION OF THE POWER DISTRICT PUBLIC INFRASTRUCTURE DISTRICT NOS. 1-3, 5-10 AND 12-13 AS INDEPENDENT DISTRICTS (THE "INDEPENDENT DISTRICTS") AND POWER DISTRICT PUBLIC INFRASTRUCTURE DISTRICT NOS. 4 AND 11 AS A SUBSIDIARIES OF UFAIR (THE "SUBSIDIARY DISTRICTS" AND, COLLECTIVELY WITH THE INDEPENDENT DISTRICTS, THE "DISTRICTS"); AUTHORIZING AND APPROVING GOVERNING DOCUMENTS; APPOINTING BOARDS OF TRUSTEES; AUTHORIZING OTHER DOCUMENTS IN CONNECTION THEREWITH; AND RELATED MATTERS.

WHEREAS, UFAIR desires to create the Subsidiary Districts as subsidiaries of UFAIR, pursuant to the Public Infrastructure District Act, Title 17D, Chapter 4, Utah Code Annotated 1953, as amended (the "PID Act"), and the Utah Fairpark Area Investment and Restoration District Act, Title 11, Chapter 70, Code Annotated 1953, as amended (the "UFAIR Act" and together with the PID Act, the "Act") for the purpose of financing infrastructure costs and providing operation and maintenance of infrastructure; and

WHEREAS, UFAIR desires to create the Independent Districts as independent districts, pursuant to the Act for the purpose of financing infrastructure costs and providing operation and maintenance of infrastructure

WHEREAS, pursuant to the terms of the Act, UFAIR may create public infrastructure districts by adoption of a resolution of the Board and with consent of 100% of all surface property owners proposed to be included in the Districts (the "Property Owners"); and

WHEREAS, the consent of such Property Owners has been obtained and it is in the best interests of the Property Owners that the creation of the Districts be authorized in the manner and for the purposes hereinafter set forth; and

WHEREAS, it is necessary to authorize the creation of the Districts under and in compliance with the laws of the State of Utah and to authorize other actions in connection therewith; and

WHEREAS, the governance of the Districts shall be in accordance with the PID Act and the terms of a governing documents (the "Governing Documents") attached hereto as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD, AS FOLLOWS:

1. Terms defined in the foregoing recitals shall have the same meaning when used herein. All action heretofore taken (not inconsistent with the provisions of this Resolution) by the Board and by officers of the Board directed toward the creation and establishment of the Districts, are hereby ratified, approved and confirmed.

2. The Subsidiary Districts are hereby created as subsidiaries of UFAIR in accordance with their respective Governing Documents. The boundaries of the Subsidiary Districts shall be as set forth in the Governing Documents.

3. It is hereby found and determined by the Board that the creation of the Subsidiary Districts as subsidiaries of UFAIR under the provisions of the PID Act is appropriate to the general welfare, order and security of UFAIR and is in the best interests of the Property Owners, and the organization of the Subsidiary Districts pursuant to the PID Act is hereby approved.

4. The Independent Districts are hereby created as independent of UFAIR in accordance with their respective Governing Documents. The boundaries of the Independent Districts shall be as set forth in the Governing Documents.

5. It is hereby found and determined by the Board that the creation of the Independent Districts as independent of UFAIR under the provisions of the PID Act is appropriate to the general welfare, order and security of UFAIR and is in the best interests of the Property Owners, and the organization of the Independent Districts pursuant to the PID Act is hereby approved.

6. The Governing Documents in the form presented to this meeting and attached hereto as Exhibit B are hereby authorized and approved and the District shall be governed by the terms thereof and applicable law.

7. The Trustees of each Board of the Districts shall be initially composed of the same members. The initial Boards of the Districts are hereby appointed as follows:

(a) For Power District Public Infrastructure District Nos. 1 and 2:

- i. Trustee 1 – Andy Marr
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Larry Mullenax

(b) For Power District Public Infrastructure District No. 3 and No. 10:

- i. Trustee 1 – Andy Marr
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Lee Fairborn

(c) For Power District Public Infrastructure District No. 4 and No. 11:

- i. Trustee 1 – Brad Holmes
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Carl Duke

- (d) For Power District Public Infrastructure District Nos. 5-8:
 - i. Trustee 1 – Brad Holmes
 - ii. Trustee 2 – Eric Carlson
 - iii. Trustee 3 – Carl Duke
- (e) For Power District Public Infrastructure District No. 9 and No. 13:
 - i. Trustee 1 – Andy Marr
 - ii. Trustee 2 – Benn Buys
 - iii. Trustee 3 – Ben Stireman

8. The Boards or the Boards of Trustees of the District (the “District Boards”) are hereby authorized and directed to record such Governing Documents, as applicable, with the recorder of Salt Lake County within thirty (30) days of the issuance of a Certificate of Creation for the District, as set forth in the Governing Document.

9. Prior to certification of the creation of the Districts by the Office of the Lieutenant Governor of the State of Utah, the UFAIR Board does hereby authorize the Executive Director, a Boardmember, or their designee to make any corrections, deletions, or additions to the Governing Documents and the Boundary Notices or any other document herein authorized and approved (including, but not limited to, corrections to the property descriptions therein contained) which may be necessary to conform the same to the intent hereof, to correct errors or omissions therein, to complete the same, to remove ambiguities therefrom, or to conform the same to other provisions of said instruments, to the provisions of this Resolution or any resolution adopted by the UFAIR Board or the provisions of the laws of the State of Utah or the United States (provided that the debt and mill levy limitations established therein may not be modified pursuant to this provision).

10. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

11. All acts, orders and resolutions, and parts thereof in conflict with this Resolution be, and the same are hereby, rescinded.



A RESOLUTION OF THE BOARD (THE "BOARD") OF THE UTAH FAIRPARK AREA INVESTMENT AND RESTORATION DISTRICT, UTAH ("UFAIR"), PROVIDING FOR THE CREATION OF THE POWER DISTRICT PUBLIC INFRASTRUCTURE DISTRICT NOS. 1-3, 5-10 AND 12-13 AS INDEPENDENT DISTRICTS (THE "INDEPENDENT DISTRICTS") AND POWER DISTRICT PUBLIC INFRASTRUCTURE DISTRICT NOS. 4 AND 11 AS A SUBSIDIARIES OF UFAIR (THE "SUBSIDIARY DISTRICTS" AND, COLLECTIVELY WITH THE INDEPENDENT DISTRICTS, THE "DISTRICTS"); AUTHORIZING AND APPROVING GOVERNING DOCUMENTS; APPOINTING BOARDS OF TRUSTEES; AUTHORIZING OTHER DOCUMENTS IN CONNECTION THEREWITH; AND RELATED MATTERS.

WHEREAS, UFAIR desires to create the Subsidiary Districts as subsidiaries of UFAIR, pursuant to the Public Infrastructure District Act, Title 17D, Chapter 4, Utah Code Annotated 1953, as amended (the "PID Act"), and the Utah Fairpark Area Investment and Restoration District Act, Title 11, Chapter 70, Code Annotated 1953, as amended (the "UFAIR Act" and together with the PID Act, the "Act") for the purpose of financing infrastructure costs and providing operation and maintenance of infrastructure; and

WHEREAS, UFAIR desires to create the Independent Districts as independent districts, pursuant to the Act for the purpose of financing infrastructure costs and providing operation and maintenance of infrastructure

WHEREAS, pursuant to the terms of the Act, UFAIR may create public infrastructure districts by adoption of a resolution of the Board and with consent of 100% of all surface property owners proposed to be included in the Districts (the "Property Owners"); and

WHEREAS, the consent of such Property Owners has been obtained and it is in the best interests of the Property Owners that the creation of the Districts be authorized in the manner and for the purposes hereinafter set forth; and

WHEREAS, it is necessary to authorize the creation of the Districts under and in compliance with the laws of the State of Utah and to authorize other actions in connection therewith; and

WHEREAS, the governance of the Districts shall be in accordance with the PID Act and the terms of a governing documents (the "Governing Documents") attached hereto as Exhibit B.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD, AS FOLLOWS:

1. Terms defined in the foregoing recitals shall have the same meaning when used herein. All action heretofore taken (not inconsistent with the provisions of this Resolution) by the Board and by officers of the Board directed toward the creation and establishment of the Districts, are hereby ratified, approved and confirmed.

2. The Subsidiary Districts are hereby created as subsidiaries of UFAIR in accordance with their respective Governing Documents. The boundaries of the Subsidiary Districts shall be as set forth in the Governing Documents.

3. It is hereby found and determined by the Board that the creation of the Subsidiary Districts as subsidiaries of UFAIR under the provisions of the PID Act is appropriate to the general welfare, order and security of UFAIR and is in the best interests of the Property Owners, and the organization of the Subsidiary Districts pursuant to the PID Act is hereby approved.

4. The Independent Districts are hereby created as independent of UFAIR in accordance with their respective Governing Documents. The boundaries of the Independent Districts shall be as set forth in the Governing Documents.

5. It is hereby found and determined by the Board that the creation of the Independent Districts as independent of UFAIR under the provisions of the PID Act is appropriate to the general welfare, order and security of UFAIR and is in the best interests of the Property Owners, and the organization of the Independent Districts pursuant to the PID Act is hereby approved.

6. The Governing Documents in the form presented to this meeting and attached hereto as Exhibit B are hereby authorized and approved and the District shall be governed by the terms thereof and applicable law.

7. The Trustees of each Board of the Districts shall be initially composed of the same members. The initial Boards of the Districts are hereby appointed as follows:

(a) For Power District Public Infrastructure District Nos. 1 and 2:

- i. Trustee 1 – Andy Marr
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Larry Mullenax

(b) For Power District Public Infrastructure District No. 3 and No. 10:

- i. Trustee 1 – Andy Marr
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Lee Fairborn

(c) For Power District Public Infrastructure District No. 4 and No. 11:

- i. Trustee 1 – Brad Holmes
- ii. Trustee 2 – Benn Buys
- iii. Trustee 3 – Carl Duke

- (d) For Power District Public Infrastructure District Nos. 5-8:
 - i. Trustee 1 – Brad Holmes
 - ii. Trustee 2 – Eric Carlson
 - iii. Trustee 3 – Carl Duke
- (e) For Power District Public Infrastructure District No. 9 and No. 13:
 - i. Trustee 1 – Andy Marr
 - ii. Trustee 2 – Benn Buys
 - iii. Trustee 3 – Ben Stireman

8. The Boards or the Boards of Trustees of the District (the “District Boards”) are hereby authorized and directed to record such Governing Documents, as applicable, with the recorder of Salt Lake County within thirty (30) days of the issuance of a Certificate of Creation for the District, as set forth in the Governing Document.

9. Prior to certification of the creation of the Districts by the Office of the Lieutenant Governor of the State of Utah, the UFAIR Board does hereby authorize the Executive Director, a Boardmember, or their designee to make any corrections, deletions, or additions to the Governing Documents and the Boundary Notices or any other document herein authorized and approved (including, but not limited to, corrections to the property descriptions therein contained) which may be necessary to conform the same to the intent hereof, to correct errors or omissions therein, to complete the same, to remove ambiguities therefrom, or to conform the same to other provisions of said instruments, to the provisions of this Resolution or any resolution adopted by the UFAIR Board or the provisions of the laws of the State of Utah or the United States (provided that the debt and mill levy limitations established therein may not be modified pursuant to this provision).

10. If any section, paragraph, clause or provision of this Resolution shall for any reason be held to be invalid or unenforceable, the invalidity or unenforceability of such section, paragraph, clause or provision shall not affect any of the remaining provisions of this Resolution.

11. All acts, orders and resolutions, and parts thereof in conflict with this Resolution be, and the same are hereby, rescinded.


