

**A RESOLUTION OF THE BOARD OF TRUSTEES OF THE CENTRAL IRON COUNTY WATER CONSERVANCY DISTRICT PROPOSING A NAME CHANGE TO "CEDAR VALLEY WATER CONSERVANCY"**

**RECITALS**

WHEREAS, the Central Iron County Water Conservancy District (the "District") is a special district duly organized under the Water Conservancy District Act; and

WHEREAS, Utah Code §17B-1-105 provides the legal mechanism for a special district board to change the name of the District; and

WHEREAS, the Board of Trustees finds that the name "Cedar Valley Water Conservancy" more accurately reflects the primary geography and water basins managed by the District; and

WHEREAS, the Board has held a public hearing on February 19, 2026, after providing proper notice as required by law.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE DISTRICT, AS FOLLOWS:**

**Section 1. Name Change Approved.**

The Board of Trustees hereby approves the change of the District's name from Central Iron County Water Conservancy District to Cedar Valley Water Conservancy District.

**Section 2. Boundaries.**

The Board reaffirms that the territory and boundaries of the Cedar Valley Water Conservancy District shall include a portion of Iron County, and the boundaries of the District shall be the same as those of Iron County as presently constituted.

**Section 3. Direction to File Notice.**


Pursuant to Utah Code §§17B-1-105(5) and 67-1a-6.7, the Board Chair and the District Clerk are hereby authorized and directed to:

1. File a Notice of Impending Name Change with the Lieutenant Governor of the State of Utah.
2. Upon receipt of the Certificate of Name Change from the Lieutenant Governor, record the Certificate along with a certified copy of this Resolution with the Iron County Recorder.

**Section 4. Effective Date.**


This name change shall become effective upon the passing of this Resolution.
