NOTICE OF IMPENDING BOUNDARY ACTION

TO: Lieutenant Governor, State of Utah

NOTICE IS GIVEN that the Town Council of Koosharem, Utah ("Council") at a regular meeting of the Council, duly convened pursuant to notice, on May 13, 2026, adopted an ordinance to annex 15 acres of land into the corporate limits of Koosharem Town.

Pursuant to Utah Code Ann. Section 10-2-407, and Ordinance 2026-05-13, the corporate limits of Koosharem Town are extended to include the property identified in Ordinance 2026-05-13 and the approved final plat.

A copy of the Final Local Entity Plat satisfying the applicable legal requirements in Utah Code § 17-23-20, approved as a final local entity plat by the Acting Sevier County Surveyor, is also attached.

The Ordinance 2026-05-13 approved the annexation of the property described in Ordinance 2026-05-13 and shown on the Final Local Entity Plat into the legal boundaries of Koosharem, Utah.

The Town Council, as approving authority, certifies that all requirements applicable to the annexation of the property into the legal boundaries of Koosharem, Utah, as more particularly described in Ordinance 2026-05-13 and shown on the Final Local Entity Plat, have been met.

The Council respectfully requests the issuance of a Certificate of Annexation pursuant to the provisions of Utah Code § 67-1a-6.5.

AN ORDINANCE ANNEXING CERTAIN PROPERTY TO KOOSHAREM TOWN.


BE IT ORDAINED BY THE TOWN COUNCIL OF KOOSHAREM TOWN, UTAH:
